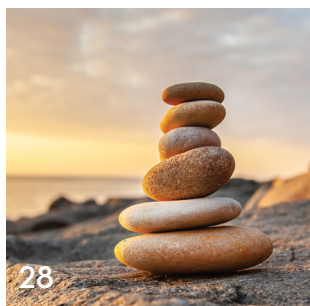
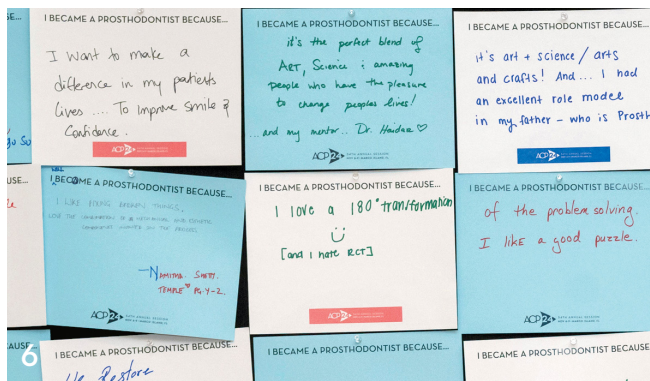

# Updates and Insights: The American Board of Prosthodontics Certification Examination, Part 1

ABP Leadership

Familiarity with the American Board of Prosthodontics (ABP) certification process helps candidates pursuing certification better understand the path ahead, and the Diplomates better appreciate continued proficiency. Since ABP certification and recertification processes constantly evolve to reflect a dynamic prosthodontic environment, open and accessible lines of communication are necessary for smooth operations. This is the first article in a series highlighting the latest ABP updates.

## In the Beginning

For a dental discipline to acquire and maintain specialty recognition by the National Commission on Recognition of Dental Specialties and Certifying Boards (NCRDSCB), a board of directors must be established to certify Diplomates.<sup>1</sup> To learn more about how this occurred in prosthodontics, review the chart on pg. 9.

Through ABP testing, prosthodontics fulfills an essential criterion for dental specialty status by recognizing clinicians who meet certification standards via rigorous examination. For a more detailed discussion on the development of the ABP, readers are encouraged to read a review published by Knoernschild and colleagues.<sup>2</sup>

After that brief historical review, it seems appropriate to move forward with a closer look at contemporary ABP decisions, philosophies, and policies that shape prosthodontic certification today.

## The Modern Examination

Although fundamental principles and practices form the basis of modern prosthodontic certification, examination development must constantly evolve to keep pace with new materials, processes, equipment, technologies, and a solid foundation in scientific evidence. Simultaneously, the examination must remain relevant and accessible to all qualified candidates to keep certification reasonably within reach. Managing these factors while maintaining the rigor of the certification process requires careful consideration, thoughtful deliberation, and frequent meetings of the ABP directors and staff. Consideration and re-consideration of exam accessibility, content, and format are a few items the ABP must routinely revisit to make timely modifications.



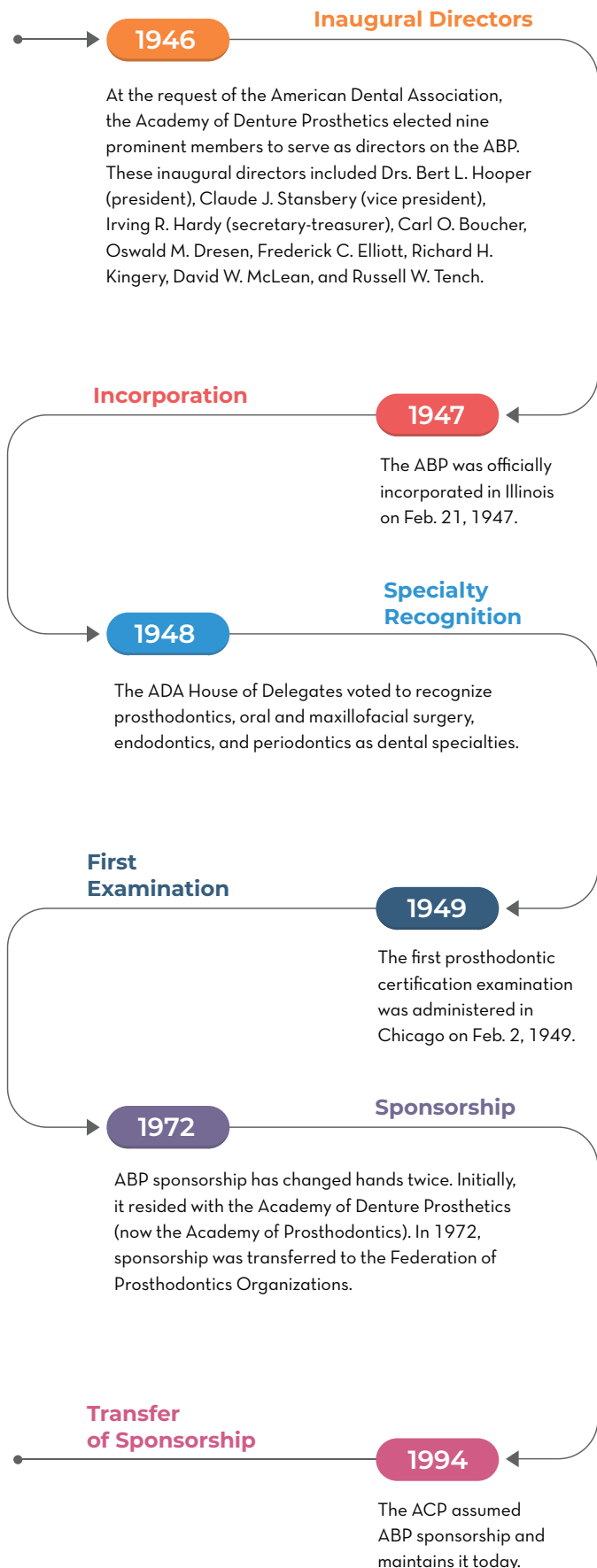
## Accessibility – Exam Venue and Timing

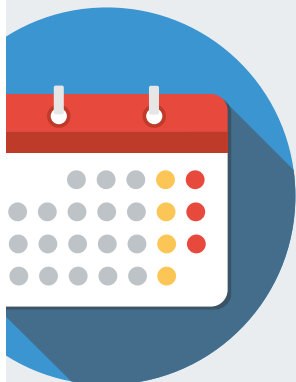
A priority for the ABP is optimizing the accessibility of the written and oral examination processes. Much effort and planning focus on administering exams at reasonably convenient times and in affordable and accessible locations.

The Section A written examination will continue to be administered at Pearson VUE regional test centers<sup>3</sup> throughout the United States and worldwide.<sup>4</sup> Starting in 2026, Section A exams will be offered within an administration window rather than on a specific date to offer candidates more flexibility in scheduling. The 2026 administration window for the Section A exam is from March 30 to April 2.

The first oral exam (Sections B, C, and D) typically held in February, will now be offered in April.<sup>5</sup> This change distributes oral exam administrations more evenly over the calendar year. It also pushes the spring exam closer to the end of the academic year for those needing to finish clinical care during the third year of their advanced training program to prepare patient presentations for oral examination.

The fall 2025 exams will no longer follow the ACP Annual Session and will instead be hosted in Dallas, TX through 2028. The Dallas venue the ABP chose is the Executive Conference suite of rooms at the Hyatt Regency DFW Airport. This executive space is a self-contained and quiet space that will be occupied exclusively by the ABP for each exam administration. Candidates and examiners will quickly appreciate the benefits of this change, including ideal examination and boardroom size and arrangement, affordable guest rooms, on-site restaurants and coffee shops, convenient accessibility of the DFW airport for national and international travelers, and readily available ground transportation between the hotel and the airport. The long-term arrangement between the ABP and the Hyatt Regency DFW Airport will facilitate long-range

- Section B, C, and D Oral Exams – The registration deadline is 60 days before the scheduled examinations.

exam planning so candidates and examination teams can more conveniently manage busy practice, academic, and advanced training program schedules.

## Rigorous but Reasonable Exam Content

The ABP is committed to constantly evolving and improving the examination process. While directors of the ABP have significant obligations to the Diplomates and exam candidates, much effort is spent during formal deliberations on (1) clarification and justification of representative prosthodontic therapy for the oral examinations that reflect contemporary prosthodontics and (2) precisely defining and updating examination expectations for candidates.

The primary means of informing potential examination candidates regarding examination expectations is the Examination Guidelines for the Certification Process – The American Board of Prosthodontics document, more commonly referred to as simply the Guidelines.<sup>6</sup> To assist potential candidates in managing document updates as the candidates move through the certification process, a dated log of modifications is maintained and published on the last pages of the Guidelines. As of the writing of this article, the Guideline Update Log (most recent to oldest updates) includes:

- Aug. 26, 2024 – Update to Section 4.1.1 Ferrule, Dental Caries, and Existing Restoration – Candidates are no longer required to replace all existing fixed prosthodontic core foundation restorations. Candidates are to replace core foundation restorations if indicated and be prepared to justify treatment decisions regarding the foundation restoration and design.
- Aug. 26, 2024 – Update to Section 6.2.1 Required Images and Documentation for Section D – Candidates are no longer required to present, for all treatments, lateral and occlusal photographs demonstrating soft tissue (emergence) contours with and without interim prostheses where utilized.
- March 18, 2024 - Update to Section 4.1.5 Requirements for the Section B, Part 2 Examination – Patient therapy may now include a complete denture or complete overdenture in the arch opposing the removable partial denture.
- Dec. 4, 2023 – Update to Section 2.2 Pathways to Certification and Stipulations – Removed language that did not allow candidates to challenge the Section C and Section D examinations during the same examination cycle. Candidates can challenge examinations at will; however, only Section C or Section D will ultimately count toward certification.



- Dec. 4, 2023 – Update to Section 2.11 Continued Proficiency or Recertification – Clarified language to indicate that certificates of Diplomate status are issued for eight (8) year periods. Active Diplomates are required to document continued proficiency and complete a recertification examination. The recertification examination can be taken at any point during the eight (8) year period.
- Dec. 4, 2023 – Update to Section 4.1 Section B General Information – Candidates are to provide two (2) paper copies of their narrative for the examiners to use during the exam.
- Dec. 4, 2023 – Update to Section 6.1 Section D General Information – Clarified how candidates must organize required patient documentation into folders on the USB drive.
- Dec. 4, 2023 – Update to Section 4.2.4 Required Radiographic Images – Clarified that digital radiographs must be of exceptional resolution and quality and that film-based radiographs are no longer accepted.
- Dec. 4, 2023 – Update to Section 6.3 Presentation Logistics – Clarified that digital radiographs must be of exceptional resolution and quality and that film-based radiographs are no longer accepted.
- Dec. 4, 2023 – Update to Section 6.2.1 Required Images and Documentation for Section D – Clarified that when 3-dimensional imaging is used in the pre-treatment and post-treatment assessment, cross-sectional images of the implant sites must be shown (cross-sectional images to include mesial-distal, buccal-lingual, and coronal slices of the implant sites).
- Aug. 1, 2023 – Update to Section 6.2 Section D Requirements and Format of Presentation – Removed the tooth-bounded and unbound edentulous space requirements. Candidates are now to present a patient treatment presentation depicting the surgical placement and restoration of a minimum of two (2) implants in one or more partially edentulous or edentulous patients.
- Aug. 1, 2023 – Update to Section 6.4 The 60-Minute Section D Examination Timeline – Clarified the timeline for the Section D timeline initiates with the candidate providing a 20-minute patient presentation, followed by 20 minutes of unrestricted questions, and concluding with 20 minutes of standardized questions related to the broad scope of implant dentistry.
- Nov. 9, 2022 – Update to Section 4.1.6 Requirements for the Section B, Part 3 Examination – Clarified that for fixed implant restorations (screw or cement retained), all dental units that provide articulating occlusal surfaces may be counted in the total number of fixed prosthodontics units.
- July 15, 2022 – Update to Section 2.11 Continued Proficiency or Recertification - Diplomates may no longer request a printed copy of the recertification examination. The recertification examination is only administered online.
- Jan. 20, 2020 – Update to Section 4.1 Section B General Information – Removed the requirement that the candidate must complete the laboratory work for one of the patient treatments in the Section B examination but clarified that candidates must have a thorough understanding of all dental laboratory procedures and



### Vision 5034

Vision 5034 is a strategic initiative of the ACP with the goal of ensuring that 50% or more of all prosthodontists become board certified within the next ten years. This initiative is designed to elevate the specialty of prosthodontics by emphasizing the importance of board certification. Keep an eye out for upcoming articles on this exciting topic!

are responsible for the outcome of all dental laboratory procedures used to complete treatment. Laboratory work authorization forms must be presented for all work a dental laboratory technician completes.

- Jan. 20, 2020 – Added Section 1.5 Protected Health Information – Clarified that candidates must remove or de-identify all patient data (protected health information or PHI). Examples of PHI and sample cropped photos were added.
- Jan. 20, 2020 – Update to Section 2.2 Pathways to Certification and Stipulations – Clarified that postgraduate students/residents may challenge the Section A written examination and any one part (2, 3, or 4) of the Section B examination beginning in the third year of formal prosthodontic training. Candidates no longer must wait until their last 6 months of formal training to challenge a Section B examination.
- Jan. 20, 2020 – Update to Section 2.4 Application Procedures – Revised the application deadline for the

Section A examination to be Jan. 31 annually, rather than 90 days before the examination date.

Updates related to exam content and recent candidate performance are also provided yearly to advanced program directors and potential examination candidates taking the ACP Board Preparation Course. # Prosthodontists, Partners, and Parents

As Dr. Jessica Canallatos and Dr. Paul Canallatos balance careers in craniofacial and maxillofacial prosthodontics while raising three young children, their mutual support keeps them thriving both professionally and personally.

Drs. Jessica and Paul Canallatos began their journey together in 2010, when they met at the University at Buffalo School of Dental Medicine. Shortly after meeting they realized their shared birthday and both being left-handed. After completing dental school, their shared passion for prosthodontics led them to West Virginia University, where they both pursued graduate training in prosthodontics. Upon graduation, Dr. Paul Canallatos continued to refine his expertise by completing a fellowship in Maxillofacial Prosthetics at the University of California, Los Angeles.

Today, they practice in Buffalo, NY, as a prosthodontist couple, balancing the demands of their careers and family life. Together, they are raising three children, ages six, four, and two, all while practicing in distinct but complementary areas of prosthodontics.

Dr. Jessica Canallatos divides her time between private practice and her role as the craniofacial prosthodontist at Oishei Children's Hospital, where she proudly holds the distinction of being the first prosthodontist employed by the hospital. Her work at the Craniofacial Center of Western New York is especially meaningful, as she was once a patient there herself. Her persistence and passion led her to become a member of the craniofacial team, where she now runs her own clinic. She specializes in treating babies with cleft lip and palate, performing NasoAlveolar Molding (NAM), and working with infants who have ear deformities through noninvasive ear molding. In addition, she treats patients of all ages, providing

prosthetic solutions ranging from speech aids to definitive implant restorations. This combination of private practice and hospital work keeps her engaged and fulfilled, making her feel like a well-rounded prosthodontist.

Dr. Paul Canallatos practices as a maxillofacial prosthodontist at Erie County Medical Center, in the Department of Oral Oncology and Maxillofacial Prosthetics. He works closely with head and neck surgeons, providing prosthetic care for patients undergoing treatment for head and neck cancers. His clinical responsibilities extend to overseeing prosthodontic care within the hospital's general dentistry residency program. Paul is deeply involved in every aspect of his patients' care, often performing the lab work himself to ensure optimal results. He is also passionate about integrating digital technology into his practice, which has significantly improved treatment times and costs for his patients. His commitment to maxillofacial prosthetics was sparked during a general practice residency at a local cancer hospital, where he was inspired by the transformative work of maxillofacial prosthodontists.

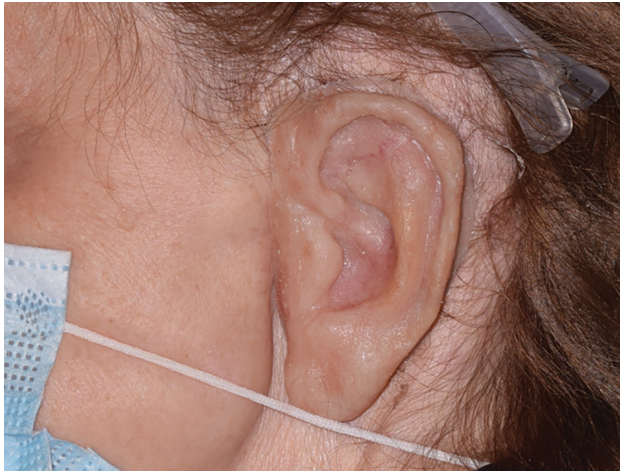

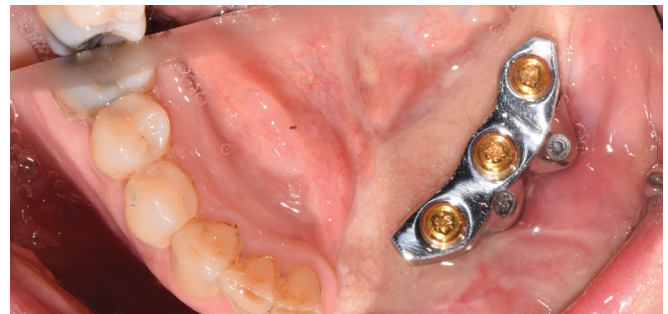

and expertise, helping each other navigate the intricacies of treatment planning, hospital administration, and the integration of digital technologies.

The American College of Prosthodontists is about the community and what we can do as an organization to create a benefit to membership in this community of specialists within dentistry.

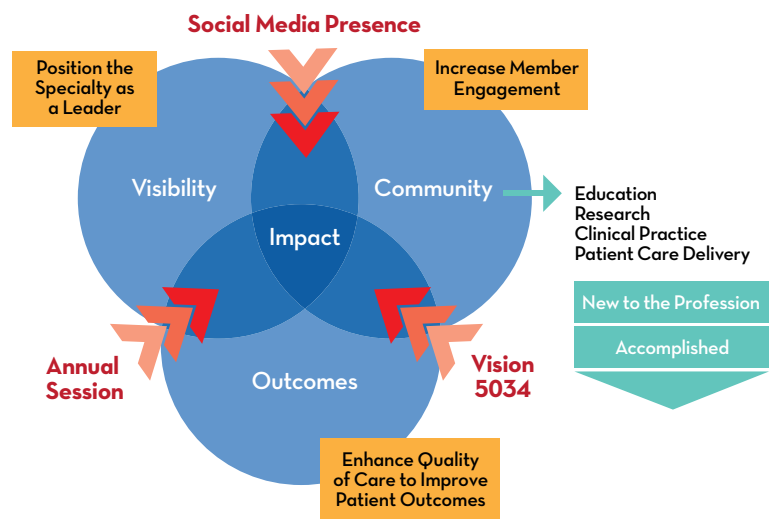
What is the strategy behind maximizing the value of membership in the ACP?

I am grateful for the dedication of our members over the ACP's 55 years working to advance the specialty of prosthodontics. ■



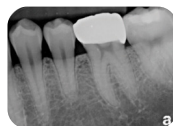
